



Dr. Russ Pratt has been the State-wide Principal Practitioner with the Office of Professional Practice in the Operations Division of the Department of Health and Human Services (Victoria, Australia) since early 2010. He holds specialist registration as both a Forensic and Counselling Psychologist, and has 20 years' experience working within the sexual assault and abuse field, in particular working with trauma, attachment, brain development, family systems, sexual exploitation and child protection issues.

Russ researches, writes and presents both nationally and internationally regarding youth exhibiting sexually abusive behaviors, the impacts of pornography on sexual practice, particularly for youth and with those adolescents who sexually harm others, and trauma, attachment and brain development issues. He is a member of the State Government's Therapeutic Treatment Board (Victoria), a member of the NSW Children's Guardian's Expert Advisory Panel, An ANZATSA board member, a Fellow of ATSA (USA), a member of the ATSA adolescent committee, and an honorary 'elder' and Board member of the National Adolescent Perpetrator Network (NAPN: USA).

Russ continues to work with sexually abusive youth and to write and research topics relevant to the field. He is currently undertaking research with Ms Cyra Fernandes from the Australian Childhood Foundation (Melbourne) on therapists' views on the impact of pornography on sexually abusive youth.

Conference Learning Objectives

At the end of the two day conference, participants will:

- 1) Identify symptoms of trauma specific to this population.
- 2) Recognize why these trauma symptoms develop in specific situations to this population.
- 3) Utilize understanding of the links between trauma, attachment and brain development and how they interact to promote outcomes.
- 4) Apply trauma-centric model of treatment to this population.
- 5) Utilize understanding of necessity for family involvement and practical application.
- 6) Describe how family systems can either support positive or problematic outcomes.
- 7) Utilize proper categories to determine appropriate risk.
- 8) Determine practical usage for tools (ERASOR, J-SOAP II) based on strengths and limitations.
- 9) Understand model and utilize with population to improve outcomes.
- 10) Apply model to client population and recognize outcomes effectiveness.
- 11) Identify pornography and its history of use and development.
- 12) Recognize how pornography impacts sexual practices across age ranges.
- 13) Apply recent research of pornography on youth specific to outcome differences for early versus later onset of first viewing age.
- 14) Utilize current treatment approaches in developing effective treatment plans
- 15) Application of treatment interventions to increase positive outcomes
